The cultural heart of Guernsey

St James, as Guernsey's premier Concert and Assembly Hall is popularly known, is a striking and prominent part of St Peter Port's elegant townscape. It is a beautiful building in the Greek revival style and, together with the adjacent Dorey Centre, offers a truly multi-functional community space used by thousands of islanders each year.

For such an important space, it often surprises users that, unlike Beau Sejour and the Princess Royal Centre for the Performing Arts, St James is maintained and operated by the Friends of St James, the charitable association responsible for administering the facility and which is supported in its efforts by a large number of local individuals and island businesses through personal and corporate membership schemes.

In 2010-2011 St James celebrated twenty-five years since the building was rescued from almost certain demolition by three far-sighted men, Richard de la Rue MBE, Rodney Collette and George Bramall.

In essence, St James is now run for all island residents by a group of dedicated staff and volunteers.

The building is owned by the States of Guernsey which remains responsible for maintaining the structure but it is leased to The Friends of St James who take responsibility for its successful operation.

While the Friends receive a small annual grant from the States to assist with operational costs, in reality St James is funded by commercial operations and annual donations. Having reached our 25th Anniversary and concerned to ensure the continued availability of St James to the

people of Guernsey, the Friends have established the St James Jubilee Foundation as a charitable trust to gather funds from well-wishers and to guarantee long-term support for this important facility.

The initial objective is to raise £500,000 to ensure that St James remains an asset for the people of Guernsey and that it will continue to thrive and be protected from most adverse circumstances.

Funds raised will not be employed to pay operational overheads or, except in extreme circumstances, to cover operational losses.

St James management and Council have day to day responsibility to ensure that losses are avoided and resources are appropriate to the revenue stream.

Foundation funds will be invested prudently and, with approval of the Trustees, may be released to the Friends of St James mainly for capital projects to support St James and develop its artistic and cultural work.



St James Jubilee

It was at a public meeting on 30 October 1815 that Guernseyman Admiral Sir James Saumarez, later Lord de Saumarez who served with Nelson, proposed the idea of building St James.

The church was to provide a place of worship for the British garrison in Guernsey, where services could be held in English because, at that time, services in the Town Church were held in French. The building, designed by John Wilson, also the architect of Elizabeth College, was completed in 1818 and it now provides an uplifting and dignified architectural focal point for the Grange.

After a full life, which, for many years included its use by Elizabeth College as a chapel, the building finally became redundant in 1970 and fell into partial decay.

The Friends of St James Association was formed in 1981 to secure the restoration of St James and then to administer the building as a concert and assembly hall. Thanks to the energetic support of a small number of States

Members, the States agreed, in 1983, to pay for its restoration and the building was officially re-opened on 5 July 1985 by HRH the Duke of Kent.

Unwilling to rest on their laurels and determined to create a truly multi-purpose centre, the Friends of St James embarked upon an intense period of fund raising to replace the simple tin-roofed annexe built during the 1930's with the Dorey Centre, completed in 2002, and which now includes meeting rooms for hire, a thriving café and administration offices.

St James now provides the island with a uniquely versatile venue for concerts and public events for a variety of tastes as well as a training, presentation and function centre for the business community.

The Trustees are prominent local individuals with an interest in St James and the cultural life of the island.

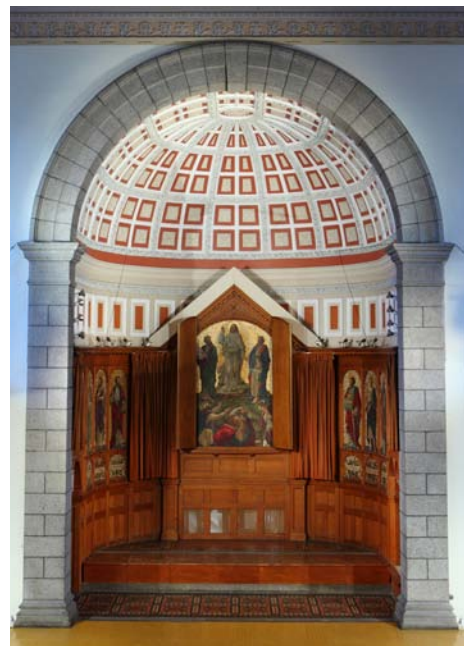
